Subject: Inviting offer for rendering free Langar Service during the Shri Amarnathji Yatra 2015 (Updated EOI).

Sir.

On behalf of Shri Amarnathji Shrine Board (SASB), we thank you once again for running a Langar Service at Domel during Yatra 2014, which concluded on 10th August, 2014.

- 2. We have since commenced our preparations for Yatra 2015 which is scheduled to commence on 2^{nd} July, 2015 from both the Yatra routes and conclude on 29^{th} August, 2015. In this context, we would like to ascertain your willingness to support the Shri Amarnathji Yatra 2015, by offering free Langar Service.
- 3. If your answer is in the affirmative, we would request you to provide us the following documents / information afresh, to enable us to timely issue the Langar Permission to your LO for setting up Langar in the Yatra area/ outside the Yatra area, for Yatra 2015, at the address mentioned above:
 - Name, full address and contact details of the Head of the LO.
 - ii) A copy of Terms and Conditions for setting up the Langar duly signed and accepted by the President/ Chairman/ Secretary of the LO/ NGO.
 - iii) A certified photocopy of the Registration Certificate of the NGO/ LO clearly showing the Date of Registration.(except nine LOs which were burnt in Baltal incident on 18th July, 2014)
 - iv) Objectives of the Organization as per its Bye-laws/

Memorandum of Association, along with a certified copy of the Bye-Laws. (except nine LOs which were burnt in Baltal incident on 18th July, 2014)

- NoC obtained from the Camp Director(s) of the Camp(s) during Yatra 2014. (except nine LOs which were burnt in Baltal incident on 18th July, 2014)
- vi) An affidavit by the President/ Chairman/ Secretary of the LO/ NGO that no criminal proceedings are lying against any member of the LO/ NGO in any Court/ Police Station / any other Statutory authority.
- 4. The following procedure shall be followed for granting Langar Permissions in respect of Yatra 2015:
 - i) an LO will be given permission to <u>set up only one Langar in</u> the Yatra area even if it has been setting up two or more Langars in the past Yatras;
 - ii) an LO may be granted permission to set up Langar at a location which may be different from the place at which it had been setting up Langar(s) during the past Yatras;
 - iii) for the establishment of a Langar at a given location, Expressions of Interest (EOI) would be invited from all those LOs who had established Langars at this location during Yatra 2014, granting them 30 days to furnish a response to the CEO;
 - iv) a Committee comprising Additional Chief Executive Officer and a Deputy CEO (to be nominated by CEO) shall scrutinize the responses received from the LOs;
 - Langar Permission may be issued to an eligible LO for setting up its Langar in the Yatra area or outside the Yatra area provided:
 - a) the reply to the EOI is received within the stipulated time period;
 - b) the documents/ reply to the EOI furnished by the LO is in order;
 - no penalty/ disciplinary proceedings is pending against the applicant LO; and
 - d) the LO has not been blacklisted by SASB and has paid the penalties / fines, if any, outstanding.

- vi) The LOs who are to be allotted sites for setting up Langars outside the Yatra area (to reduce the number of Langars from certain existing locations) will be identified as follows:
 - the LOs which had set up their Langars for the first time during Yatra 2014;
 - ii) followed by those LOs which had set up their Langars for the first time during Yatra 2013 and so on.
- 5. You are further requested to deposit an amount of Rs. 10,000 (Rs. Ten thousand only) in the form of an Account Payee Demand Draft in favour of Shri Amarnathji Shrine Board. (in case, you have not taken refund of the deposit or the deposit has not been forfeited by SASB, you are not required to deposit Rs. 10,000).
- 6. If it is decided to issue a Permission Letter in favour of your LO, you will be timely informed so that you have at least 30 days time to send us the names, residential address, contact numbers, **Police Verification Report** and two passport size photographs, **Compulsory Health Certificate (CHC)**, in respect of all the *Sevadars* to be deployed by you, issued by the doctors/ institutes nominated by the respective State Government enabling us to timely issue the Photo Identity Cards.
- 7. The Langar Organizations are requested to send their responses directly to this office by registered / speed post.
- 8. Please ensure that the response, along with a copy of Terms and Conditions for setting up the Langar, duly signed and accepted by the President/ Chairman/ Secretary of the Organization, reaches us by 16th April, 2015, latest.
- 9. The responses received after 16th April, 2015 shall not be considered for the accord of Langar Permissions by CEO, SASB.
