Yatra 2021 on non exclusive basis

Detailed terms and conditions in respect of Tender Notice Issued under No: SASB/DNIT/843/2020/30 Dated: 25.08.2020.

1. On behalf of the Chairman, Shri Amarnath Ji Shrine Board, Srinagar (J&K), sealed bids are invited from the Television Channel Companies desirous of seeking permission in regard to Live Telecast of Aarti before the Holy Cave of Shri Amarnathji, twice a day (of about half an hour duration each) at "Holy Cave Shrine" for a period of **three** years, during Yatra period on **non exclusive basis subject to the following eligibility conditions:**

- i) The bidder must possess necessary permission from the Ministry of Information and Broadcasting, Government of India for up linking a Television Channel, for which the bidder shall submit necessary documentary evidence. Besides, the bidder must furnish the documentary evidence of the permission with regard to undertaking the live up-linking, granted by the Ministry of Information and Broadcasting. The bidder must own the teleport facility for linking up a Television Channel, for which the bidder shall submit necessary documentary evidences.
- ii) The bidder must submit an affidavit sworn before Judicial Magistrate First Class that it shall ensure securing timely permissions from the Ministry of Information and Broadcasting, Government of India, for up linking a Television Channel, which shall, on standalone basis or on repetitive renewal basis, cover the entire period of license i.e. 03 years from the date of issue of letter of Award/ signing of Agreement as the successful bidder.
- iii) The bidder must submit attested copies of Audited Balance Sheets and profit and Loss account of last three years viz. 2017-18, 2018-19 and 2019-20.
- iv) The bidder must be an Income Tax Payee. The bidder shall submit attested copies of the Income Tax returns/ Income Tax Assessment Order for 2017-18, 2018-19 and 2019-20 and shall also submit PAN detail

- v) The minimum reserve bid for the non exclusive license shall be Rs. 450 lakh + GST 18% for three years i.e., Rs 150 lakh plus GST18% per year.
2. The bidder shall submit his / her offer in two bid format containing the **Technical Bid and the Financial Bid as per the details noted below:**
- a) The Technical Bid shall contain the duly signed tender document in acknowledgement of acceptance of the terms and conditions contained therein, Pre-Qualification Bid as per Schedule-A, Technical Proposal indicating all relevant details, documentary evidence in support of eligibility and details of experience with supporting documents, Earnest Money Deposit for the prescribed amount and the back ground details of the Company. All the documents forming the Technical Bid shall be properly sealed in a separate sealed cover **duly superscribed as "Technical Bid"** along with NIT No. and Name of the bidder.
- b) The Financial Bid shall be furnished as per the format at Schedule-B and properly sealed in a separate cover duly superscribed **"Financial Bid"** along with NIT No. and Name of the bidder.
- c) Both the covers sealed independently shall then be placed in the third sealed cover, which shall be suscribed "Tender for live Telecast of Aarti" along with the NIT No., date and the name / address of the bidder.
3. The bidder shall clearly specify in figures and words the amount of bid, which the bidder is prepared to pay. Offer below the prescribed Reserve Bid shall not be considered. Any quotation written in pencil shall be rejected. The tender entries shall be typed or written in ink and should be legible. There should not be any erasing or over-writing or fluid corrections. If any corrections have been made, the same shall be neatly done and properly signed by the bidder, without which the bid shall not be accepted. If there is any inconsistency between the figures and words, the amount as appearing in words will be considered.
4. The bidder is advised to, in its own interest, visit the site of operation before submitting the tender. Criteria for succesful bidder shall be: (a) Expierence (b) Coverage (c) Technical Support & (d) Infrastructure of the Company / Agency.

5. Tender form along with detailed terms and conditions can be obtained from the Office of the Shri Amarnathji Shrine Board, Chaitanya Ashram, Talab Tillo, Jammu between 10.00 AM to 5.00 PM, on any working day on cash payment of Rs. 5000/- each. The tender form can also be downloaded from our website www.Shriamarnathjishrine.com which shall be accompanied with Demand Draft of Rs. 5000/- drawn in favour of the Chief Accounts Officer, Shri Amarnathji Shrine Board, Chaitanya Ashram, Talab Tillo, Jammu.
6. The tenders must be completed in all respects before submission. All terms and conditions of the tender should be carefully studied for ensuring submission of complete and comprehensive offer. The bidder shall put his/ her signature and specify in the capital letters the name along with parentage with his/ her complete postal address on the tender form and shall duly sign the terms and conditions attached thereto at the space mentioned therein.
7. The date of opening of Financial Bids shall be intimated only to the eligible short listed bidders after evaluation of Technical Bids. The Financial Bids shall be opened in the presence of such short listed bidders as may 'choose to be present on the date and time of the opening of the Financial Bids.
8. All offers must be sent through registered letter / reputed courier service or be put in the sealed tender box kept in the Central Office for the purpose. The tenders must be received latest by the date and hour prescribed for submission of such tenders. SASB shall not be responsible for any delay what-so-ever in the receipt of these tenders. The tenders shall be opened on the same day or any other day convenient to the undersigned, in presence of such bidders or their authorized representatives, as may choose to be present.
9. Canvassing in connection with tenders in any form is strictly prohibited, and if resorted to, will render the bidder disqualified.
10. The successful bidder shall be required to accept all the terms and conditions of the NIT and shall have to execute a formal agreement deed with the authorized representative of Shrine Board, in which all the terms and conditions of the license shall be indicated, and the licensee shall be bound by all such terms and conditions. The conditions in this tender notice are subject to variations and modifications, which shall also be incorporated in aforesaid agreement deed and only thereafter the licensee shall be allowed to commence the permitted operations. The legal

expenses, which shall be incurred in the execution of the agreement, shall be borne by the said bidder.

11. The bidder shall deposit the amount (as indicated in the tender notice) in the form of (FDR/TDR), as earnest money, pledged to the Chief Accounts Officer, Shri Amarnathji Shrine Board, Chaitanya Ashram, Talab Tillo, Jammu failing which the tender would not be considered.
12. The EMD (in the form of FDR/TDR only) of the successful bidder shall be retained and the same shall be refunded, on the satisfactory completion of the contract, while those of the unsuccessful bidders shall be returned after the finalization of the tender proceedings.
13. The licensee shall ensure installation of the required infrastructure, bandwidth, connectivity and delivery platforms purely on temporary and removable basis at its own cost. No liability shall accrue to the Shrine Board on any account. However, Shri Amarnathji Shrine Board can facilitate carriage of equipments/ staff to and fro through heli services on chargeable basis as per agreement with the heli services, if licensee shall desire so. The licensee shall arrange food for staff to be deployed at its own cost.
14. The video / voice data shall be an exclusive property of the Shrine Board. The licensee shall, under no circumstances, use the feed of video / voice data of Aarti for sharing with / selling to any other channel / agency etc for commercial purpose or otherwise, without securing a written permission from the Chief Executive Officer, Shri Amarnathji Shrine Board on mutually agreed terms and conditions. The Shrine Board reserves the right to consider or reject any such request by the licensee.
15. There shall be no commercial break or display of any advertisement during the live telecast of Aarti. The cameras should be placed to cover the maximum possible area. The light and glare should be minimum and should be capable of zooming in as per the requirements.
16. The successful bidder shall ensure display of *messages / scrolls* during live telecast as desired by SASB, from time to time. The bidder shall also make sure to advertise the promos related to the live telecast of Aarti one month before at the reputed channels.

17. The bidder shall have to comply with all directions / suggestions of the Board regarding any alternations or modifications in the content or presentation of the Aarti at any time during the period of the contract.
18. That on receipt of any complaint from the pilgrim / Yatri / Officer / Official of the Shrine Board on account of violation of terms and conditions of the NIT or misbehaviour with the staff / yatris etc. or displaying of any unauthorized contents during the live Aarti, the fact shall be got verified through an officer duly authorized by the Chief Executive Officer / Additional Chief Executive Officer for the purpose. If the complaint upon verification is found true, the Licensor will be at liberty to impose monetary penalty amounting to Rs. 50,000/-(Rupees Fifty Thousand Only) on the Licensee for each complaint, which the licensee shall be bound to pay, failing which the license can be revoked. In case of recurrence of such verified complaint, an additional penalty of Rs. 20,000/- per case shall be levied over and above the basic penalty amount i.e. Rs 70,000/- for second violation and Rs. 90,000/- for third violation. Any instance of more than 3 violations of NIT can invite termination of license and forfeiture of EMD.
19. The licensee shall at all times fully cooperate with the management at Holy Cave of Shri Amarnathji and comply with the spot instructions given by the authorities from time to time.
20. The licensee shall ensure round the clock monitoring of its installations and equipments and ensure that no damage is caused to any life and property. At any point of time, any damage, if caused, shall be the sole responsibility of the licensee, who shall have to fully compensate for the same to the entire satisfaction of the Shrine Board.
21. Safety and security of the equipment shall be the sole responsibility of the licensee and Shri Amarnath ji Shrine Board shall not be liable for any damage caused whatsoever.
22. The licensee shall abide by all the rules and regulations, as amended from time to time, notified by the Shrine Board and maintain sanctity of Shrine and not indulge in any activity which is prejudicial to the sanctity of the Holy Shrine. Staff of the licensee shall not indulge in smoking or consumption of liquor/alcohol or consumption of any non vegetarian food articles. They shall maintain proper

- decoram and discipline, and ensure proper conduct in speech and dress. They shall also refrain from any other activity which might hurt the sentiments of pilgrims.
23. The video / voice data from the feed shall not be used for any other commercial activity, including production of movies, films, songs, serials, documentaries, advertisements etc. The telecast agency must ensure uninterrupted high quality of video as well as audio and quality of telecast should be par with the Digital Standard Parameters. There should be no compromise of quality in audio / video at any cost.
 24. The licensee shall at all times ensure that its activities do not disturb, in any manner, the smooth management of pilgrimage. In case of violation of this condition, the license is likely to be revoked without any prior notice.
 25. The licensee shall ensure that entire feed of Aarti shall be telecast ensuring the full sanctity of the Holy Shrine. The licensee shall also ensure that for wide publicity; the live telecast of Aarti should be linked with the social media App like U-Tube.
 26. The uplinking of Aarti shall be undertaken on the channel that has been telecasting atleast 10 hours of religious / spiritual content on a daily basis for atleast two years as on 01.09.2020 in support of which a self declaration in the shape of an affidavit shall be submitted as a prerequisite for the consideration of the proposal. The assertions made in the affidavit, if found false / erroneous at any stage, shall attract the rejection of the proposal, forfeiture of EMD / security deposit, revocation of licence (if allotted) and blacklisting of the firm from participation in any of the future NITs for a period of 5 years."
 27. The Shrine Board reserves its absolute right not to accept any tender/offer at any stage before execution of license deed. In case the Shrine Board decides not to accept any tender/offer in whole or in part, it shall not be required to assign any reasons thereof to the bidder.
 28. The Chief Executive Officer / Additional Chief Executive Officer reserve the right to negotiate the amount of bid, after opening of tenders, before offering the non-exclusive license, in the larger interest of the Shrine Board.
 29. If the bidder, as a Partner / Director of a company, is a defaulter, owes by himself or by proxy or on behalf of any other person, any money dues, in any connection what-

so-ever, to the Shrine Board, his tender shall not be considered unless he / she clears his / her outstanding as determined by the Shrine Board before submission of tender. In case the Board detects here to after or comes to know about it, the CEO / Addl. CEO shall be at liberty to take any action, including the revocation of license.

30. The licensee shall have no right to make any addition, alteration, improvement, change or even affect any repair in the premises to be used in connection with live-telecast operations without the prior written approval of the Chief Executive Officer / Addl.Chief Executive Officer, SASB.
31. The successful bidder shall have to deposit an amount payable on yearly basis on pro-rata basis vis-a-vis the total bid amount and an irrevocable unconditional Bank Guarantee for an amount equivalent to that payable for a year on pro-rata basis vis-a-vis the total bid amount and valid for at least 35 months, within 15 days from the date of acceptance of tender and before the execution of the license deed. The mere acceptance of tender, without the payment of the amount as noted above and submission of the afore-mentioned Bank Guarantee shall not confer any right upon the bidder to enjoy the permission for live telecast of the Aarti.
32. In case the successful bidder fails to deposit the amount mentioned at Clause 31 above along with furnishing of bank guarantee equivalent to an amount payable for one year (one year) on pro-rata basis vis-a-vis the total bid amount, (as referred to in the para 31 above), within the stipulated period of 15 days from the date of acceptance of the tender, or any such period extended by the Competent Authority of the Shrine Board, his earnest money received in the form of FDR / TDR shall stand forfeited in favour of SASB without any notice and SASB shall be at liberty to initiate re-tendering or to consider any other eligible bidder for allotment of the license.
33. The balance amount (other than the payment for a year on pro-rata basis vis-a-vis the total bid amount made before signing of the Agreement) shall be payable in advance as yearly payment (in favour of Shri Amarnath ji Shrine Board) from the date of commencement of the License Deed, and in case any such payment (in advance at the beginning of each year) is not made, the Bank Guarantee already furnished at the time of signing of the License Deed shall stand invoked and proceeds thereof realized against the balance license fee payable for the remaining

license period. Such an eventuality shall be treated as violation of the license deed and shall render the license revoked with necessary consequences.

34. The Chief Executive Officer / Addl. Chief Executive Officer shall be at liberty to revoke the license in case any condition of the NIT / Agreement is violated, and in that case the licensee shall be prohibited to continue his operations and shall remove his / her demur without any objection. In addition to and without any prejudice to the right of the Shrine Board to terminate the permission / agreement for violation of the obligations / conditions of the Agreement / NIT or the Law, Shrine Board shall have the right to terminate the license / contract by giving two months notice in writing for whatever reason. In such an event Shrine Board shall be under no obligation to give any reasons for its decision to put to an end of the agreement license. Moreover, the second party shall also have the right to end the agreement by serving three months prior notice in writing. However, such an action of the second party shall not entitle it for recovery of the license fees on proportionate basis.
35. The period of license will commence from stipulated date in the Agreement to be signed and shall expire on the completion of a period of three years from the date so indicated. Simultaneously, with the expiry of the period of the license, i.e. three years from the date of the signing of license deed, the license granted in favour of the licensee shall be deemed to have been revoked and the licensee shall forthwith remove his belongings without any demur failing which SASB shall be at liberty to remove all such articles, at the cost of licensee. In this regard, no notice would be required to be given to the licensee.
36. The licensee shall not transfer, share, sublet or assign-the telecast permission either wholly or in part to any other party or person. If it is found at any stage that the permission is actually being enjoyed through proxy, through a person other than the Licensee himself or if it transpires that the financial status of the Licensee is not commensurate with the bid amount, the Shrine Board shall have the right to cancel the license forthwith after confiscation of the deposited license fee and forfeiture of the Security Deposit.
37. The bidder shall clearly specify the number and names of such channels on which it proposes to undertake the live telecast of the Aarti. The profile of each channel

along with specific details and cumulative time slots of religious programmes telecast on the channels shall be submitted by the bidder. While quoting the offer, the bidder shall clearly indicate the bid for each of such channel and as also the cumulative bid amount. The CEO / Addl. CEO Shrine Board reserve the right to accept or reject the whole proposal or a part of it.

38. The bidder shall also specify whether the channel shall telecast the Live Aarti for the viewers abroad (overseas) and that whether the firm possesses the permission / rights for transmission abroad. The bidder shall have to specifically quote for such transmissions abroad.
39. The Shrine Board shall not be responsible for any loss or damage caused to the equipment etc belonging to the licensee, on account of any natural calamity.
40. The licensee shall have to abide by all relevant restrictions imposed and relevant orders issued by the Shrine Board from time to time, in this behalf.
41. The electric / water / telephone connection facility shall be provided by the Shrine Board along with the accommodation for the team who will be stationed at Holy Cave for Telecast. Accommodation charges will be paid by the company as per rules given below:
 - i) 4 Bed Hut with attached Toilets, Rs. 2000/- plus GST applicable per day
 - ii) 6 Bed Hut with attached Toilets, Rs. 3000/- plus GST applicable per day
 - iii) Police Verification and Compulsory Health Certificate of the staff deployed be furnished to SASB 15 days before the commencement of Yatra.
42. It shall be the responsibility of the Bidder to obtain all the necessary licenses / permissions and to ensure that all the statutory and legal requirements, rules and regulations for the operation of telecast of live Aarti are fully complied with. The bidder alone shall be responsible for all consequences, which may arise directly or indirectly on account of the breach or non-observance of statutory or other legal requirements.
43. The premises used by the licensee at Holy Cave shall be subject to inspection by the Chief Executive Officer / Additional Chief Executive Officer or any other officer authorized by the said authorities at any point of time.

44. If the licensee fails to abide by any of the terms and conditions of the agreement deed, his license shall stand revoked and FDR / TDR forfeited in favour of the Shrine Board.
45. All disputes and differences between the parties hereto pertaining to or arising out of this agreement and all matters connected therewith shall be referred to the arbitration of a person to be nominated / appointed by the Chief Executive Officer of Shri Amarnathji Shrine Board whose decision shall be final and binding upon the parties.
46. Any of the parties may apply to the Chief Executive Officer, SASB for the appointment of the Arbitrator in the event of any dispute / difference. On receipt of such request, it shall be lawful for Chief Executive Officer to appoint an Arbitrator to adjudicate upon the disputes / differences. The Arbitrator so appointed shall enter upon the reference and decide the disputes in accordance with J&K Arbitration Conciliation Act 1997. Place of Arbitration shall be at Jammu.
47. The Courts at Srinagar / Jammu alone shall have jurisdiction to decide upon the dispute between the parties.
48. The bidders shall deposit an amount of Rs. 22.50 lakh (Twenty two lakh and Fifty thousand only) i.e., 7.50 lakh per year as Performance Security Deposit in the form of Bank draft in favour of Chief Accounts Officer Shri Amarnathji Shrine Board Chaitanya Ashram, Talab Tillo, Jammu before the execution of the agreement and within 15 days of the issue of letter of Intent failing which no further correspondence shall be made and the EMD deposited shall be forfeited to cover any unsettled liabilities unpaid dues including penalties for any violations of the terms and condition of this agreement.
49. The Chief Executive Officer, Shri Amarnathji Shrine Board shall be at liberty to suspend the arrangement due to any Force Majeure conditions and shall not be responsible for loss of revenue to the agency in the event of suspension of Yatra such as Government regulations wars, Orders, accidents creating disturbed conditions, terrorist activity, strikes / riots, Civil commotion etc. Inclement weather and / or natural disasters and unforeseen circumstances or any other reasons.

50. The Shri Amarnathji Shrine Board shall not be liable for any damage or liability of any kind arising out of force Majeure conditions and / or any other cause beyond the reasonable control of the SASB.
51. The intresting bidders may attend the office of SASB at Chaitanya Ashram, Talab Tillo, Jammu on 17th September at 11:00 AM for any clarification in this regard.
